This Privacy Policy sets out the basis on which we process any personal information we collect about you or that you provide to us.

About us

Information we collect about you

We collect and process the following information about you:

- Information you provide to us. You can provide us with information about you by filling in forms on our website or by contacting us by telephone, email or otherwise.
